Boater Safety Zone Update Initiative Workshops

Three **Boater Safety Zone Update Initiative Workshops** are planned over the next few months. Manatee Protection Plan

On April 20, 2017, the FWC Commissioners approved the proposed changes to the manatee protection zones in Collier County that were formally recommended on January 10, 2017. The final rule language, found in 68C-22.023, FAC, has been filed for adoption with the Florida Department of State and were made effective on February 19, 2018.
